Course Goals: This course is designed for senior undergraduate students who are pursuing a BS degree in biochemistry. The goals of this course are to provide training in: oral presentations, literature reviews, and poster presentations. This will be accomplished through a combination of lectures, workshops, reading, interviews, group discussions, and writing assignments. The overall objective of the course is to provide training in areas critical to success in a job or academic pursuit that may not be covered in traditional courses. These topics are essential to success in a biochemistry related job, graduate work, or professional school.

Texts: There is no assigned text for the course.

Canvas: Information essential to the course will be available through the course Canvas page. This site is found at canvas.usu.edu. Only students who are registered for the class will have access to the course pages.

Grading: This course will be graded based on the points received for the elements presented below (table). Final letter grades will be assigned based on the percentage of the total points possible with the following scale: A's 100%-90%, B's 90%-80%, C's 80%-70%, D's 70%-60%, F below 60%. Attendance at all of the assigned meetings is essential. A missed event can be made up at the discretion of the Professor. Activities required to make-up missed events will be decided by the Professor in consultation with the student. Missing more than two of the events will result in zero points for all missed events with no option for make-up. Assignments turned in after the deadline will have 2 points deducted for each 24 h period late.

Communication Intensive

This course qualifies as Communication Intensive (CI) being focused on developing both scientific writing and presentation skills. The assignments described below are designed to allow you to present and write, with feedback from the instructor and your peers. All of the assignments are designed to provide feedback as you develop these presentation skills.

Assignment Overview:

Departmental Seminars

You will attend weekly seminars hosted by the department and provide a short evaluation of the presentation. Evaluations are required for 8 of the 10 seminars this semester.

Assignment 1: Finding and organizing literature

The assignment is meant for you to practice gathering and organizing literature using the major databases and collecting citations and papers using Zotero. Details of the assignment are provided in Canvas.

Assignment 2: Quick presentation of a paper

In this assignment, you will do a quick presentation to the group of a recent biochemistry paper you have pulled from the literature. No formal presentation. The emphasis is on organizing thoughts and presenting clearly.

Assignment 3: Discussion of paper/topic for seminar (+ peer review)

In this assignment, you will present the essence of the paper/research you will do your poster and presentation on. No slides. Emphasis is on having a clear story. You will meet with one of the biochemistry faculty to discuss the selection of your paper.

Assignment 4: Key Slides for poster and talk (+ peer review)

You will present the key slides that will be the heart of your talk and poster. The format will be slide-by-slide discussion among the group to improve the slides and logic.

Assignment 5: Presentation to group

You will give your 10 min presentation to the group without interruptions to gauge timing and delivery. The group will give critiques following each presentation.

Assignment 6: Poster

You will present a poster to the entire department. Poster details will be provided on a separate assignment description.

Assignment 7: Seminar Presentation

You will give a formal presentation to the department. Grading will be on clarity of presentation. Grading details are in a separate document.

ACS Biochemistry Exam – Mon, May 2, 2:30-4:30 PM, ESLC 053

Because this is the capstone course for all of our biochemistry majors and it is important for us to understand the preparedness of our graduating majors, you will take the standardized ACS Biochemistry exam as a part of this course. The exam is worth a total of 10 points and will be taken in person during the final exam period for this course.

Plagiarism

Plagiarism includes knowingly "representing by paraphrase or direct quotation, the published or unpublished work of another person as one's own in any academic exercise or activity without full and clear acknowledgment. It also includes the unacknowledged use of materials prepared by another person or agency engaged in the selling of term papers or other academic materials." The penalties for plagiarism are severe. They include warning or reprimand, grade adjustment, probation, suspension, expulsion, withholding of transcripts, denial or revocation of degrees, and referral to psychological counseling.

Grievance Process

Students who feel they have been unfairly treated [in matters other than discipline, admission, residency, employment, traffic, and parking - which are addressed by procedures separate and independent from the Student Code] may file a grievance through the channels and procedures described in the Student Code: Article VII Grievances

Sexual Harassment

Withdrawal Policy, "I" Grade Policy and Dropping Courses

If a student does not attend a class during the first week of the term or by the second class meeting, whichever comes first, the instructor may submit a request to have the student dropped from the course. (This does not remove responsibility from the student to drop courses which they do not plan to attend.) Students who are dropped from courses will be notified by the Registrar's Office through their preferred e-mail account.

Students may drop courses without notation on the permanent record through the first 20 percent of the class. If a student drops a course following the first 20 percent of the class, a W will be permanently affixed to the student's record (check General Catalog for exact dates).

Students with extenuating circumstances should refer to the policy regarding Complete Withdrawal from the University and the Incomplete (I) Grade policy in the General Catalog.

No-Test Days Policy

For classes that meet for a full semester, a five-day period designated as "no-test" days precedes final examinations. During this time, no major examinations, including final examinations will be given in order that students may concentrate on classwork, the completion of special assignments, writing projects, and other preparation for duly scheduled final examinations. Approved exceptions include final papers, weekly chapter quizzes, quizzes, projects, and examinations associated with a lab that does not meet during final examinations. This policy does not apply to classes that meet only during the second 7-week session of the semester or to classes offered during the summer term. Assumption of Risk
